Dear Mr. Micallef,

Following the phone call earlier today, I would like to provide an update regarding the replacement water spout (mižieb) for the Church of St Roque in Balzan.

Officials from the Superintendence of Cultural Heritage (SCH) have visited the site to assess the new spout. Upon examination, it has been noted that the newly carved water spout deviates slightly from the existing twin water spout. Specifically, the original spout has a slimmer profile and smaller proportions compared to the replacement.

As a result, the SCH recommends the following steps.

1. The new water spout should be taken to the site.
2. Measurements should be taken from the existing water spout before any modifications are made to the new one.
3. The replacement spout should be adjusted on-site to match the dimensions and details of the original spout.
