The SCH has been verbally delegated by your goodselves to proceed with remedial action at the site in cap.

Further to email hereunder site was inspected by SCH and the damage confirmed as reported.

Damage consists of a broken water spout (mizieb) in globigerina limestone during works on a neighbouring site.

Contractor is:

- i) Robert Micallef
- ii) ID no 117671(M)
- iii) Mob 9949 8550
- iv) Company RMX limited

Attached images consist of :

- a) broken water spout (fragments have unfortunately been disposed of).
- b) Intact water spout that is to be used to take dimensions from and carve a copy in globigerina limestone.
- c) Police report courtesy of the Very Rev'd Parish Priest of Balzan, Msgr Carmelo Farrugia.

The SCH has communicated with Mr. Micallef today and he admitted the damage. He apologized for this and consequently expressed his intent to carry remedial works asap. The recommended advice of the SCH is that a replica - in new globigerina limestone - of that shown in image indicated in (b) above is undertaken asap and installed on site.
