This project will entail the restoration of the altar painting by Francesco Zahra depicting Saint Francis of Assisi. This painting has long adorned the side altar in question. In fact, the historian Carm Bonavia, in his article 'Lejn Titular Inkurunat', states that by 1747, all the side aisle altars had the paintings as we know them today. However, over the years this painting has suffered considerable damage as can be seen from the conservator's report. Urgent intervention is required to prevent the irreparable loss of this work of art.
